Ms. Wendy Smith stated that the Operations Report had been distributed by the Controller's Division. She reported that toll revenues for the month of January had outpaced last year by 2.9% and were above the OTA's estimate by 1.7%. With only one month complete, OTA had underspent the annualized budget by 16.4%.

Item #2. Consulting Engineer Report

Mr. Jimmy Sparks presented the Consulting Engineer Report for the month of January 2016. Concerning the Trust required services; Olsson had completed bridge inspections for the 2016 report year and submitted the data to the FHWA. Culvert inspections had started and pavement inspections would begin in April. Olsson was working with OTA on the implementation of a pavement management system that would assist in prioritizing both short and long-term needs of the System.

Mr. Sparks also stated that Turner Turnpike Bridge No. 31.3 repair plans had been completed and the project was awarded earlier in this meeting.

Mr. Kelly asked Mr. Sparks to elaborate on the pavement management plan and if OTA currently had a plan in place. Mr. Sparks stated that OTA did not have a formal plan in place. While this plan may not be as robust as ODOT's, it was a paver system, which was developed by the Corps of Engineers. Once you input your history, it will allow you to look at your system as a whole and then be able to drill down to project specific needs. Mr. Kelly asked what standards were used in ranking those. Mr. Sparks stated that the Pavement Condition Index was the main system.

Item #3. Highway Patrol Report

Major Rusty Rhoades presented the OHP Report. For the month of January 2016, Troopers made 9,894 violator contacts and assisted 1,386 motorists. There were 74 motor vehicle collisions investigated in January with five fatalities reported; one on the Creek and four on the H. E. Bailey Turnpike. There were also five criminal interdictions on the Muskogee and Will Rogers Turnpikes. Major Rhoades stated that the information for aircraft, motorcycle enforcement and toll enforcement had been provided in the monthly report. Mr. Kelly asked Major Rhoades to comment on the troop strength. Major Rhoades gave a brief overview how the current cadet academy was progressing and stated that they had 797 troopers to date.

Item #4. Director's Report

Mr. Alan Freeman stated that the Driving Forward Program was progressing. A public meeting was held in Choctaw on February 18, 2016 to provide information on the Eastern Oklahoma County Turnpike (EOC) project and to receive input from the public regarding the project. There would be another EOC meeting in approximately four weeks, which would be communicated once set and confirmed. He also commented that there was a public meeting being held that evening (2/23/16) for the Kilpatrick Extension at the Mustang Town Hall to provide information and receive input from the public. Other components of the Driving Forward Program were also proceeding with projects to be let in a spring or early summer timeframe.

Mr. Freeman also noted that Ms. Dana Weber would be confirmed in the Senate Transportation Committee Meeting being held later that afternoon by Senator Stanislawski to serve the unexpired term of Former Board Member, Kevin Hern. He also updated the Board on the health status of Mr. McCaleb.

Secretary Gary Ridley commented on the EOC public meeting that was held in Choctaw, stating that there was some misinformation previously given out regarding the EOC turnpike. During the next public meeting, the proposed alignment would be presented for public comment and input. From that meeting and input, engineers would design limits of the new alignment, which would also be brought back to the public. There would be a lot of input between now and the final product. Mr. Ridley also briefly commented on the right of way process and property acquisition.

Mr. Kelly adjourned the Authority Meeting at 11:02 a.m. until the next scheduled Regular Meeting of Thursday, March 31, 2016 at 10:30 a.m.
